The undersigned further (1) irrevocably consents to jurisdiction and venue in the Circuit Court of Douglas County in Nebraska, in connection with any dispute arising out of or relating to this Guaranty and (2) agrees that no litigation of any such dispute shall be commenced in any other Court. The rights and obligations of the parties shall be governed by and the validity and interpretation of this Guaranty shall be determined in accordance with the law of the State of Nebraska (except the conflicts of laws rules of that State).
